- **3.** <u>Code of Conduct</u>: INDs shall abide by the Code of Conduct for Members of the Board and Senior Management as laid down by the Company.
- **4.** Remuneration: INDs shall be paid sitting fees and be entitled to reimbursement of expenses for attending the Meetings of the Board/Committee(s) of the Board and also entitled to Profit sharing commission as may be decided by the Board from time to time.
